Article 1, Section 1C

Not necessarily. House must create budget and rein in other branches thereby

Article 1, Section 2C

He believes property taxes should be phased out

Article 1, Section 5C

Again, phase out property taxes

Article 6, Section 2

Believes federal environmental policy should be ended. Not a federally enumerated responsibility

Article 6, Section 5

Believes we should advocate congressional action to end (not limit) presidential authority in creating or expanding national parks and monuments

Article 6, Section 7

We encourage the State of Idaho to reestablish (not seek) authority to oversee the utilization of natural resources on federal lands within the state.

Article 16, Section 3B

Believes we should eliminate penalties for plant consumption

Article 17, Section 6
